### 1. Acknowledgment

You acknowledge and agree that tastytrade, Inc. ("tastytrade") owns all right, title and interest to its middleware and trading platform (the "tastytrade System") and to its customers' access to the tastytrade System via mobile, web, and downloadable software applications (collectively, the "tastytrade Applications").

Furthermore, you acknowledge and agree that tastylive, Inc. ("tastylive") owns all right, title and interest to its webbased and downloadable application (the "tastylive App") and all content, documentation and related materials streaming, displayed or connected to it (collectively, the "tastylive Content").

You acknowledge that tasty*live* is not a licensed financial advisor, registered investment advisor, registered broker-dealer or FINRA, SIPC, or NFA member firm. tasty*live* does not provide investment or financial advice or make investment recommendations. tasty*live* is not in the business of transacting trades, holding customer funds or securities, nor does tasty*live* agree to direct your brokerage accounts or give trading or investment advice tailored to your particular situation. #### 2. Grant of Licenses

tastytrade hereby grants to you a revocable, non-transferrable, non-exclusive, limited license to use the tastytrade System via the tastytrade Applications for purposes, including, but not limited to, trade routing and execution, access to market data, and account management.

All of tastytrade's copyright and other intellectual property rights, including, but not limited to, patents, logos, trademarks, the tastytrade System, and the tastytrade Applications shall be and remain the sole property of tastytrade. You agree not to reproduce, retransmit, disseminate, sell, distribute, publish, broadcast, circulate or otherwise exploit tastytrade's copyright and intellectual property rights in any manner without tastytrade's express written consent. You agree to comply with reasonable written requests by tastytrade to protect the tastytrade System, the tastytrade Applications, and tastytrade's respective rights therein.

tastytrade, as a fully owned subsidiary of tasty*live*, hereby grants to you a revocable, non-transferrable, non-exclusive, limited sublicense to use the tasty*live* App for the purpose of providing front-end trading platform technology.

All of tastylive's copyright and other intellectual property rights, including, but not limited to, patents, logos, trademarks, the tastylive App, and tastylive Content shall be the sole property of tastylive. You agree not to reproduce, retransmit, disseminate, sell, distribute, publish, broadcast, circulate or otherwise exploit tastylive's copyright and intellectual property rights in any manner without tastylive's express written consent. You agree to comply with reasonable written requests by tastylive or tastytrade to protect the tastylive App, tastylive Content, and tastylive's respective rights therein.

Nothing in this End User License Agreement grants you any ownership of or any rights in tastytrade, tastylive, or any affiliate of either party's intellectual property. You agree to not use the tastytrade System, the tastytrade Applications, the tastylive App, or tastylive Content for any illegal purposes.

You acknowledge that there are no expressed or implied warranties or representations provided by tastytrade relating to the licensed use of the tastytrade System and the tastytrade Applications, services or facilities used to support the tastytrade System and the tastytrade Applications, including, but not limited to, the validity of the market data transmitted to you, warranties of merchantability, non-infringement, and warranties of fitness for a particular purpose, or implied warranties arising from trade usage or course of dealings.
